PROVIDING A HOLISTIC CARE PROGRAM OF FOOD PACKAGES AND EMERGENCY FOOD VOUCHERS, MET COUNCIL IS MEETING THE COMPLEX NEEDS OF STRUGGLING NEW YORKERS. AT THE SAME TIME, ALL NUTRITIONAL RESOURCES ARE AVAILABLE TO ANYONE IN NEED, WHETHER THEY KEEP KOSHER OR NOT, REGARDLESS IF THEY ARE JEWISH OR NOT. FOR EXAMPLE, MET COUNCIL SUPPLIED OVER 30 HALAL FOOD PANTRIES WITH HALAL CERTIFIED FOOD FOR MOSTLY IMMIGRANT CLIENTS ACROSS NEW YORK.
